For very small and emergent companies, individual membership will be more beneficial, but AASA requests that larger companies do not misuse this opportunity as AASA depends greatly on the corporate membership income. Corporates that want to link more than 5 employees or large commercial entities that want to provide AASA with additional support will be dealt with on a one to one basis. • <u>Institutional</u> membership is for institutions such as Universities, Government Departments, nongovernmental organisations etc. and also allows for the logging of 5 people within the institution to AASA for information, materials and discounts.
